It **supports doctors and patients in reading and managing their data from around 350 medical devices and data interfaces** such as blood glucose meters, insulin pumps and blood pressure monitors.

The Connection Center is therefore an important building block for data interoperability in the treatment of chronic diseases.

The Connection Center forms a **bridge between medical device manufacturers and health portals** (e.g. for Roche, LifeScan, CompuGroup, TELUS Health, Alberta Health).

Once patients have created an account with a health portal, they can download the Connection Center app from the Internet, install it on their PC and import data. They can then grant doctors or carers access to their data.

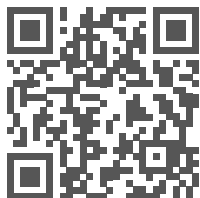
